Baseline Review

Over 130 Nursing In-patient units and emergency rooms have been reviewed to understand current staffing levels and skill mix, in preparation for implementation of the Direct Patient Care Needs Assessment.

DID YOU KNOW?

A shared objective of the SNSC is for review of and response to nurse staffing concerns across Fraser Health. Here are some actions taken to improve staffing:

- Rotation change underway at Abbotsford Regional Hospital ER, providing 50% part time positions.
- Temporary seasonal positions are being implemented at Eagle Ridge Hospital, Langley Memorial
 Hospital and Ridge Meadows Hospital to care for 8-10 patients per site and decrease admitted patients
 in the ER.
- Langley Memorial Hospital ER: To better understand the challenges, a working group comprised of employer and local union representatives will review flow and staff assignment.
- Bi-monthly reporting of vacancy rates at Abbotsford Regional Hospital and Surrey Memorial Hospital emergency rooms. Success! Both are showing improvement.
- Over 800 casual RNs and LPNs responded to our survey in December. Results to be shared in early 2020. Thank you for your sharing your feedback in the survey!
